AFFIDAVIT OF MICHAEL P. STARCEVICH


I, Michael P. Starceвич, of lawful age, first being duly sworn upon oath, and upon personal knowledge, state as follows:

1. I am a resident of the state of Oklahoma.
2. I am a Class Member in the referenced case because I am a royalty owner in the Chesapeake operated Wade 3-32 well.
3. I have had the opportunity to discuss the litigation and the Settlement with class Representative. I have also had an opportunity to review the Notice and the materials available on the website. Based on my discussion with Class Representative and my review of these documents as well as my experience as a royalty owner, I believe the settlement is fair and provides a great result for the Class.
4. I appreciate and support the work Class Counsel has done. Without their efforts, I would not have recovered any of the past amounts that QEP Energy Company is paying in settlement. Also, without their efforts I would not have pursued individual litigation in this case and would not have had a recovery. As I understand it, the actual royalty owed to the Class approximately \$43.5 million. The cash portion of the Settlement provides more than two and a half times that amount. I believe this is a great result.
5. I approve the settlement and believe that attorney fees in the amount of 1/3 of the total settlement value of \$155 million dollars including cash amount of \$115 million dollars and

future benefit value of an estimated \$40 million dollars should be awarded. I believe such an award is justified. Additionally, I support class representatives receiving an award of ½ of 1%, in the aggregate, is appropriate for the prior work and future work in helping audit the future royalty payment methodology. Based upon my understanding of what the Class Representatives have done and achieved here, I believe such an award is appropriate. Especially given the fact that Chieftain Royalty Company has also agreed to continue to serve the Class by exercising its audit rights for years to come, such an award is all the more deserved. Lastly, I support reimbursement of the requested expenses. I believe that these amounts are fair and should be awarded.

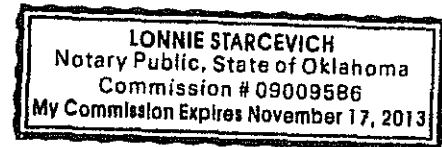
